



Dog Classes Registration



- Participating dogs and puppies must be licensed under Maui County, current on their vaccinations as appropriate to their age, and on flea and tick prevention. Owners must provide proof of vaccination history.
- Make sure your dog has a well-fitted buckle/flat collar and a six-foot leather, nylon, or cotton leash. No choke chains, prong collars, or e-collars. No retractable leashes, chains, or ropes.
- Bring small, soft, smelly treats and your dog's favorite toys. Soft jerky treats, hot dogs, or cheese cut into small pieces is preferred. Do not feed your dog 4 hours prior to class.
